1. SUBJECT

- 1.1. This MoU has been created to formalise the partnership between Gambia Women's Chamber of Commerce and Landward Research.
- 1.2. This MoU commenced on 2nd June 2021
- 1.3. The partnership will end whenever the CEO or President of either of the two partners notifies the other by email that they want to end the relationship.
- 1.4. Each partner will be free to promote and advertise our partnership as we wish.
- 1.5. The partnership will continue to engage in other projects and other related activities as it deem fitting for the purpose of its objectives.

2. COMMITMENTS

Both parties commit to:

- 2.1. Seek opportunities to work together in project development and delivery.
- 2.2. Provide occasional supportive information, advice and guidance on funding and development opportunities.
- 2.3. Ensure we aren't entering into competition with each other.
- 2.4. Accountable and judicious disbursement of financial dividends and commitments

3. AMENDMENTS

3.1. The MoU can be amended with the written notice agreement of both parties. For the sake of this MoU, written agreement can include email.

4. BREACHES

- 4.1. If one of the parties does not fulfil its commitments, the other party may give them written notice, setting out the nature and particulars of the breach together with relevant supporting documents.
- 4.2. On service of a Breach Notice, the Chief Executive Officer of partner A and Chief Executive Officer of partner B (together 'the Chief Executive Officers') shall attempt in good faith to resolve the dispute.
- 4.3. If the Chief Executive Officers are unable to resolve the Dispute within 30 days of it being referred to them, the MoU will be dissolved after settling all commitments prior

The parties affirm to know, understand and agree to all articles of this MoU as negotiated together.


